**Enrollment Contract 2025-2026**

I/We hereby enroll my son/daughter, \_\_\_\_\_ in Grade \_\_\_\_\_, for the 2025-2026 Academic Year and agree to the following terms and conditions.

1. I/We understand and agree that the **registration fee of \$1,500 is non-refundable** and is considered an enrollment fee and immediately and unconditionally earned. This is separate from the tuition fee. **Enrollment is only secured once the contract is signed and the non-refundable deposit is paid.**

2. I/We understand and agree that the current **total tuition is \$19,500** for the grade in which my student is enrolled. **Parents who pay full fees and tuition within 30 days of signing this contract are eligible for a \$1,500 discount.**

3. I/We understand and agree to any minimal additional fees such as Chorus, Culinary, Event, Sports, and Senior Fees.

4. I/We understand and agree that as of the first day of classes attended by my student for the 2025-2026 Academic year, I/We /are financially **responsible for the entire tuition** for the Academic Year. I/We further understand and agree that my obligation to pay the tuition for the full academic year on or after the first day is unconditional and that no portion of such charges so paid or outstanding will be refunded or canceled. (Please note that the school's expenses are incurred on an annual basis with the hiring of teachers and staff predetermined based upon your enrollment and agreement to fulfill your obligation).

5. It is understood that students may be required to withdraw from Trinity Preparatory School because of disregard for major rules and regulations (Code of Conduct), violation of law, personal maladjustment, prolonged academic deficiency, or any evidence of lack of positive parental cooperation. If such a circumstance occurs, I/We understand and agree that regardless of any previous payment plan agreed to, I/We will be financially responsible for the remainder of the total balance as of the date withdrawn or full tuition is due on the scheduled dates or immediately if such date(s) has passed.

6. I/We agree to use **ACH/CC** payments and understand that a monthly 1.5% Finance Charge will be added to balances over 30 days past due, and transcripts and grade reports will be withheld from students with outstanding balances. I/We agree to pay any such finance charges. I/ We also agree to pay a fee of \$25.00 for any checks returned from the bank and/or for "insufficient funds," and attorney's fees and costs to collect balances due. I/We agree to pay a 3.5% handling fee for all credit card charges.
